## (1) Writing Form:

The manuscript is limited to Chinese or English, and the manuscript should be typed on a computer (Word version). Contributors should submit a long abstract (Attachment 2) and the basic information sheet of the contributor (Attachment 1) by online submission to facilitate the review and editing of the paper. The content of the long abstract should include the purpose, importance, methods, results discussions, and references of the research, and only present the necessary diagrams, and narrow the scope of visibility to avoid occupying space. The number of words (including punctuation and references) should be at least 1,000 words, and at most 2,000 words, with no more than three pages.

## (3) Review Results and Method of Publication:

The paper is expected to be reviewed in late August. Those who fail the review can choose to publishby a poster. The list of oral and poster articles will be announced on the website of CSEE on September 1. It is expected that the seminar agenda will be scheduled and announced in mid-September. There will be real-time comments and interactions between experts and scholars in the oral presentation. The publisher is invited to report in person on line. The long abstract will be included in the conference CD.
